TERMS AND CONDITIONS FOR THE DISPOSAL OF VEHICLES:

1. As per the directions of the State Transport Authority, Govt. of NCT of Delhi, the transfer of ownership of auctioned/condemned vehicle cannot be considered. However, a "No Objection Certificate" may be obtained from the Registering Authority for such vehicle for re-registration elsewhere outside NCR Region. The formalities have to be completed by the purchaser.
2. An EMD of ₹ 5,000/- (Rupees Five Thousand) only for each vehicle in the form of Demand Draft in favour of "**PRINCIPAL, RAJKUMARI AMRIT KAUR COLLEGE OF NURSING**" should accompany the bid. The bids without EMD or in any other form i.e. cheque or cash etc. will be summarily rejected. The bid can be submitted for any vehicle but the EMD should be in multiple of number of vehicle/s, bid is submitted for, i.e. if the bid is one/two vehicle/s the amount of EMD should be ₹ 5,000 / ₹ 10,000/- respectively. Bidder/s can bid for any number of vehicle/s as per their suitability and convenience.
3. In case the offer is rescinded, abrogated or withdrawn by any bidder, the EMD deposited by him/her shall be forfeited. No representation in this regard shall be entertained by Rajkumari Amrit Kaur College of Nursing (RAKCON).
4. The earnest money of the successful bidder will be released only after the bidder deposits the sale proceeds. **Earnest money will be forfeited if the successful bidder fails to honor the bid.**
5. **The last date of receipt of bid/ quotation is by 3.00 P.M. on 22.11.2017.** The bids shall be opened on the same day at 4.00 P.M. in the Assembly Hall of RAKCON. The tenderers or their representative (not more than one), who wish to be present at the time of opening of bid/ quotation, may do so.
6. **The bid/ quotation shall be kept valid for a period of 45 days from the date of opening of bid/ quotation i.e. 22/11/2017..**
7. The bids received after the stipulated date and time i.e. after 3.00 P.M. on 22.11.2017 will be summarily rejected. The bids received through E-mail/Fax/Telegram will not be considered. However, bids through speed post/registered post will be considered only if received before the stipulated date and time.
8. The successful bidder has to deposit the entire bid money within five working days after the opening of the bid i.e. by 05.00 PM 27/11/2017. EMD will not be adjusted as sale proceeds. **The EMD of ₹ 5,000/- for each vehicle will be forfeited in case the bidder backs out for whatever reason/s.** The EMD of unsuccessful bidder/s will be returned only after successful completion of sale proceeds.
9. The prospective bidder has to submit authenticated documentary proof of his/her address. The documentary evidence in support of residential status is Aadhar Card/ Voter Identity Card/ Passport in case of individual and Registration Certificate in case of Firms etc. The delivery of sold vehicle/s will be arranged only after the successful bidder submits these documents. **The undersigned reserves the right to verify the antecedents/documentary proof of his/her address from the concerned authorities.** In the absence of the information, the bid/quotation

shall not be entertained.

10. All interested bidders have to furnish self-attested copy of PAN/TAN/GST number along with the bid documents.

11. The bids with overwriting/cutting/erasing in the quoted rates will render the entire tender invalid.

12. Submission of tender bid/quotation will signify the acceptance of all terms and conditions of the contract as above. It will not be obligatory for RAKCON to accept the highest bid/quotation & no explanation shall be given for the cause of rejection of bid/quotation to any bidder.

13. If it is found that the amount quoted by the successful bidder (i.e. highest bidder) is less than the reserve price fixed by the Airport Authority of India or the total number of bidders was less than the three, the bid may be treated as cancelled.

14. The bid amount by the successful bidder will be deposited within five working days either in pay order/ demand draft in favour of **“The Principal, Rajkumari Amrit Kaur College of Nursing”** payable at New Delhi. **No other mode of payment will be accepted under any circumstances.**

15. The successful bidder/s has to remove the vehicle/s from the premises of RAKCON at their own cost **within 3 working days of final payment. In case of delay in removing the vehicle/s beyond 3 days, a penalty of Rs.200/- (Rupees Two Hundred) only per day per vehicle shall be imposed for the next seven days and thereafter the EMD along with other deposits shall be forfeited.** No representation or any claim for refund in this regard shall be entertained by RAKCON. No assistance / transportation for removing the vehicle/s will be provided by RAKCON. Permission to take out the disposed vehicle from RAKCON premises will not be allowed on holidays, Saturday and Sunday, etc.

16. In case the successful tenderer fails to remove the vehicle in above prescribed time, even after depositing the contract amount, this office has right to forfeit Earnest money as well as penalty in removing the vehicle as mentioned above and take punitive actions as deemed fit by the Department. In this case, the quotation of H-2 firm will be considered.

17. The bidders will not be allowed to withdraw their bids under any circumstances, failing which their earnest money deposit (EMD) will be forfeited.

18. In case the highest quoting firm (H-1) fails to honor the bid; the contract will be cancelled and its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible bidder (H-2 firm) to complete the bid provided it is prepared to accept the prices offered by the H-1 firm.

19. The vehicle shall be used for bonafide/ lawful purpose only.

20. The vehicle/s will be disposed of on **“As is where is basis”** and no guarantee to its roadworthiness or quality etc. is given by the RAKCON.

21. The successful bidder shall be required to submit documentary evidence in support of residential status i.e. Aadhar Card / Voter Identity Card/ Passport in case of individual and Registration Certificate in case of firm/company etc.

22. The successful bidder will be responsible for getting the Registration Certificate of the



vehicle transferred in his/her name at his/her own cost expeditiously. The RAKCON will not be responsible for any lapse on his/her part in this regard.

23. The undersigned reserves the right to accept or reject any/all of the bids/quotations without assigning any reason/s. Canvassing in any form will be considered as disqualification from the award of contract.

24. Tenderers are requested to quote their rates both in figures and words and on firm and final basis.

25. All taxes/levies etc. will be borne by the buyer over and above the bid price.

26. Employees of RAKCON and their blood relations are not eligible to participate in the bidding process.

27. The bid is not transferable and the successful bidder will not be allowed to sell the vehicle/s within the premises of RAKCON.

28. Bidder shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.

29. Bid/ Quotation should be offered in proforma as given at Page nos.5 & 6 of this document.

30. EMD of unsuccessful bidders shall be returned within three weeks of the award of contract to successful bidder.

31. Disputes, if any, shall be subject to jurisdiction in the Court of Delhi only.
