IMPORTANT INSTRUCTIONS FOR THE CANDIDATES
REPORTING FOR ADMISSION

1. All the Candidates who have been allotted seats at R.A.K. College of Nursing by MCC, DGHS are required to bring the following original documents at the time of reporting for admission:
 - a) **Provisional Allotment letter by MCC.**
 - b) **NEET Rank letter and Result (both)**
 - c) **NEET Admit Card**
 - d) **Identity Proof : Adhaar Card/Voter ID**
 - e) **Secondary School Examination (10th) certificate** as a proof of date of birth / Date of Birth certificate
 - f) **Senior Secondary School Examination (10+2) or equivalent Examination certificate** and mark-sheet with 50% or more marks in the aggregate of 4 subjects including English, Physics, Chemistry and Biology provided the student has passed in each subject separately (Practical & Theory).
 - g) **Scheduled Caste/ Scheduled Tribe/OBC (non-creamy layer)/ EWS certificate** issued by competent authority if applicable. The validity of the non-creamy layer and EWS certificate shall be for the financial year 2025-26, issued after 31st March, 2025.
 - h) **Certificate of recent good conduct 2025** from the educational institute last attended or by a Gazetted Officer(within six months).
 - i) **Two passport size photographs** as pasted on the application form/admit card.
 - j) **One set of self- attested copies of all the above documents.**
 - k) *** Anti-ragging Affidavit by the Parents/Guardian**
 - l) *** Anti-ragging Affidavit by the students.**
Students have to fill online undertaking on the link https://www.antiragging.in/affidavit_registration_disclaimer.html and bring the acknowledgement copy of same for submission at college.
 - m) **Candidates seeking admission against reserved seats for PwD** should bring with them the original Medical Certificate issued to them by an authorized Medical Board.
 - n) **Candidates seeking admission against reserved seats for wards of Ex-Servicemen** are required to bring the original certificate issued by the competent authority in prescribed performa.
2. Candidates who have been called for admission are required to bring with them two Demand drafts / Pay orders of **Rs.11930/- & Rs.13455/- (Hostler) and Rs.9830/- & Rs.**




255/- (Non-Hostler) respectively in favour of "**PRINCIPAL, R. A. K. COLLEGE OF NURSING**" payable at **New Delhi**.

Candidates belonging to SC and ST Category, whose parent's income is such that they are not paying Income Tax, are exempted from the payment of Tuition Fee. However, a declaration to that effect will have to be given in writing by the parents seeking exemption.

3. Fee has to be deposited by the selected candidates **during Reporting/Joining date of MCC counselling schedules**. Candidates who fail to fulfill the admission formalities **or do not deposit the fee will lose their claim for the admission**.
4. It is mandatory for all candidates to be present in person along with their Parents/Guardians while reporting to the Institute for admission.
5. Candidates will have to make their own arrangements for travel and stay in New Delhi while reporting to the Institute for admission.
6. All admissions are subject to verification of authenticity of the original certificates / documents of the candidates, if any discrepancy is found, the allotted seat and admission will be cancelled. The decision of the admission committee regarding the eligibility of any applicant shall be final.
7. The candidates are requested to visit the website www.mcc.nic.in Ministry of Health & Family Welfare, Government of India and www.rakcon.com regularly for updated information.
8. No individual communication will be sent for the admission.
9. Students are informed to bring one passport size photograph of their parents, local guardians and self for hostel records.


