

G.S.R.....- In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the College of Nursing, New Delhi (Class III posts) Recruitment Rules, 1971, in so far as they relate to the post of Office Superintendent, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment of the post of Office Superintendent in the Rajkumari Amrit Kaur College of Nursing, New Delhi, Ministry of Health & Family Welfare namely:-

1. Short title and commencement. - (1) These rules may be called the Ministry of Health and Family Welfare, Rajkumari Amrit Kaur College of Nursing, New Delhi, Office Superintendent(Group 'B') Recruitment Rules, 2026.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and level in the pay matrix. - The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age-limit, qualifications, etc. - The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification. - No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax: - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with union public service commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving. - Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Upper Division Clerk in RajKumari Amrit Kaur College of Nursing with ten years of regular service in Level-4 (Rs 25,500-81,100) in the pay matrix and have successfully completed mandatory training of two weeks in the relevant field as prescribed by the Ministry of Health and Family Welfare.

Note : Where Juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying service or two years whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

Deputation : Officers under the Central Governments or State Governments or Union territories:

(a) (i) holding analogous posts on regular basis in the cadre or Department :or

(ii) with 10 years' service in the grade rendered after appointment

thereto on a regular basis in posts in level-4 in the pay matrix (25,500 - 81,100 ) or equivalent in the parent cadre or department ; or

(iii) with 6 years' service in the grade rendered after appointment thereto on a regular basis in posts in level-5 in the pay matrix (29,200 - 92,300 ) or equivalent in the parent cadre or department and

b. possessing the following educational qualifications and experience :

i. Bachelor Degree from a recognised University or Institute ; and

ii) Two years' experience in Administration, Establishment work in a Government office or Public Sector Undertakings or autonomous body or statutory body.

Note 1: The period of deputation including period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not
