

Notification

G.S.R.....- In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the College of Nursing, New Delhi (Class III posts) Recruitment Rules, 1971, in so far as they relate to the post of Stenographer(Grade-I), except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment of the post of Stenographer(Grade-I) in the Rajkumari Amrit Kaur College of Nursing, New Delhi, Ministry of Health & Family Welfare, namely:-

1. Short title and commencement. - (1) These rules may be called the Ministry of Health & Family Welfare, Rajkumari Amrit Kaur College of Nursing, New Delhi, Stenographer Grade-I (Group 'B' post) Recruitment Rules, 2026.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and level in the pay matrix. - The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age-limit, qualifications, etc. - The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification. - No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax: - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with union public service commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving. - Nothing in these rules shall affect reservation, relaxation of age-limit and

other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Stenographers Grade-II, of the Rajkumari Amrit Kaur College of Nursing, Lajpat Nagar, New Delhi, with ten years regular service in the Level 4 in the Pay Matrix (Rs. 25500-81100).

Note: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their senior shall also be considered provided they are not short of the requisite qualifying or whichever eligibility service by more than half of such qualifying or eligibility service or 2 years, never is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

Deputation (including short term contract):

Officers under the Central Government or State Governments or Union territories or recognized Research Institutions Universities or Public Sector Undertakings or Semi-Government or Statutory or Autonomous Organizations:

(a) (i) holding analogous post on regular basis in the parent cadre or department: or

(ii) with ten years regular service in the Stenographers grade in the Level 4 in the pay matrix (Rs. 25500-81100).

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation (including short-term contract) including the period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years.

Note 3: The Maximum age limit for appointment by deputation (including short term contract) shall be not exceeding fifty six years as on the closing date of receipt of applications.
